

## Maud Morgan Arts Adult Scholarship Policy

Maud Morgan Arts offers both full and partial scholarships. Scholarships are limited to two students per course and one independent rental student each semester, and offered on a first come first serve basis. The cost of additional materials is not included in the scholarship.

The scholarship amount is determined based on the applicant's current income. Income verification (paystub, form 1040, etc.) is required to process the scholarship application. See scholarship amounts and eligibility below.

Students must be enrolled in a class to be eligible for a scholarship. Because registration often fills very quickly, students should register for a class as soon as it opens to reserve their spot, and apply for scholarships separately. Once it is determined if the student is eligible for a scholarship, their tuition will be waived or they will be invoiced for the remaining tuition. If the student is not awarded a scholarship, they can choose to either pay full tuition or to withdraw from the class at no cost.

Applications must be received by the deadline in order to be considered. Once the scholarship amount is determined, the remaining tuition must be paid ten days prior to the start of class. If you are interested in setting up a payment plan to pay the remaining tuition, please contact us.

If a class does not reach the minimum enrollment to run, full refunds for any tuition paid will be issued by Maud Morgan Arts. Scholarships are not transferable to other sessions or courses, but students are encouraged to re-apply in future semesters.

To calculate your eligibility, find the row that matches your household size (household is typically yourself, your spouse, and any dependents). That row contains the max monthly and annual incomes for the various scholarship levels. Income that exceeds the rightmost column (over 500% of the poverty line) will not be eligible for any scholarships.
